Dear Mr Bam

Cape Town is blessed with unique and globally significant biological riches. This treasure trove reveals to us that, on the Table Mountain chain alone, we have nearly as many species of plant found in the entirety of British Isles.

In Cape Town, where many cities might have streets named after indigenous flora & fauna, we name our suburbs after indigenous vegetation. Neighourhoods such as Heathfield, Lotus River, and Grassy Park itself, was the source of much of the thatching reed for Cape Town in the early days of the City's history.

But, while much of this biodiversity has been lost or is imperilled, there is still much left to fight for. It is hence that we provide our full support to the *Imagine Princess Viei: The People's Vision* initiative.

It represents in many respects the best approach for urban conservation: a coming together of diverse parts of our society to develop an exciting and innovative common vision for what is a public asset – Princess Vlei. It is only with full community participation and ownership that we can fully harness the potential of our precious urban conservation spaces. WWF experienced this with the Cape Flats Nature Project and we see the same elements of good practice in place here.

Topical, but by no means the only focal point, is the potential inappropriate commercial development of a waterside shopping mall with associated parking lots and taxi ranks at the Vlei.



The "People's Vision", which was developed and submitted for consideration as a World Design Capital 2014 project, was drafted around placing people and their well-being at the centre of nature-based development of the space, involving restoration of the natural vegetation around the littoral zone, development of nature based recreational space, recognition of the cultural heritage value and historical community use of the site.

We see all of this as being in line with the spirit of the City's aspirations to be a global leader and innovator in urban design capital. This could not be more appropriate, since the City and its citizens are already custodians of globally significant and important biodiversity.

We therefore wish the Princess VIei Forum, its Management Committee, the leaders and the diverse contributors, the very best in developing the initiative and delivering on its vision.
